- **13.** Consideration of items to be taken in private (Exclusion of Public and Press):
- There are only a few reasons as to why, legally, the public and press can be excluded from a meeting. The Public Bodies (Admission to Meetings) Act 1960 Sec 1 (2) states "A body may, by resolution, exclude the public from a meeting (whether during the whole or part of the proceedings) whenever publicity would be prejudicial to the public interest by reason of the confidential nature of the business to be transacted or for other special reasons stated in the resolution and arising from the nature of that business or of the proceedings; and where such a resolution is passed, this Act shall not require the meeting to be open to the public during proceedings to which the resolution applies." It is generally considered acceptable to exclude the press and public if the agenda item relates to the consideration of tenders, leases, purchases of assets, for matters relating to staffing covered by the Data Protection Act and to consider complaints against the council or a code of conduct complaint.

8.6 Flood and Drainage Warden Report.

Work on relining the sewers started in early December 2024 and took several weeks. They will finish up in January 2025, and hopefully, this will mean we will not need to have tankers pump out over the winter when the Nailbourne flows.

A request was made through the Dover portal to dig out the sump and the swale, but it has not been done yet.

It is difficult to get through by telephone despite several attempts, but Andy Hudson from highways drainage has told me he is monitoring it. This year has been much drier, and so far, the Nailbourne hasn't started to run.

A work party in autumn tidied up the Vicarage meadow, and some branches overhanging the ditch were trimmed. This will help reduce the amount of leaves falling into the ditch.

Leaves have been regularly cleared from the barrier across the ditch at the Short Lane end and put into the compost bins.

The workmen at the building site have been informed that the field floods and that they need to move their toilets along a bit; otherwise, they could be under water!

9.1 Highways Update - January 2025


Kent Highways are still considering our proposals to enable Alkham Highways Improvement Plan to move on.

In response to our last request for an update, they asked us to "bear with them" and trust that they have Alkham Parish Council's requests and desires in mind and in hand. There is still a considerable amount of work and investigations that need to be carried out before they can come back to us with firm information and decisions.

However, in an important concession, it has been agreed internally within Kent Highways to proceed with these investigations prior to receiving a design fee so they can ensure that they can do all they can but ensure Alkham Parish Council will not be out of pocket should they not be able to deliver.

Speed Checks - Alkham Valley Road

Good afternoon,

Earlier today, myself and my colleague PC Eyre-Jackson conducted proactive speed enforcement checks on the Alkham Valley Road prior to entering the village of Alkham. This was within the 40mph stretch of road heading in the direction of Folkestone. Offending drivers were stopped in Glebelands and dealt with for necessary traffic offences.

We issued four tickets for speeding offences and also one driver was reported for driving without third party insurance.

We will return to this location and carry out further unannounced checks with colleagues from the Community Safety Unit over the coming weeks and months.
